A certificate must be obtained at the Brazilian Consulate at origin country to avoid taxes. Additionally, in order to be tax exempt, the owner of the move must not have exceeded 44 days in Brazil during the twelve months before the definitive return. Alternatively, in case customer has spent 45 or more days in Brazil in the twelve months before definitive return to Brazil, customs will require that you have lived abroad 12 months plus the quantity of days over the 44 days. Example: customer spent 80 days in Brazil. Therefore, customer must prove to have lived abroad 1 year + the difference between 80 – 45 = 35 days. So, customer needs to have lived abroad for 1 year + 35 days to have tax exemption. <p><b>Fumigation of imported and exported wooden crates</b></p>		<ul style="list-style-type: none"> <li>▪ The Brazilian Government adopted ISPM-15 (International standards for Phytosanitary Measures Publication 15) Guidelines for Regulating Wood Packaging Material in International Trade (aka NIFM-15) to standardize the treatment of wood packing materials used for the transport of goods.</li> <li>▪ Effective September 2005, shipments into or out of the country in wooden packaging, need to have a Seal, certifying that these have received the required treatment (HT = Heated Treatment - a minimum wood core temperature of 56°C for a minimum of 30 minutes; or fumigation with Methyl Bromide (MT).</li> <li>▪ The minimum temperature should not be less than 10°C and the minimum exposure time should not fall below 16 hours.</li> <li>▪ The treatments established in the present regulation intend to reduce the introduction and/or the dissemination of quarantine plagues associated to the wood packing.</li> <li>▪ The wood packing material must be marked in a visible location on each</li> </ul>	<ul style="list-style-type: none"> <li>▪ This regulation DOES NOT apply to wood</li> <li>▪ packing materials manufactured of: <ul style="list-style-type: none"> <li>▪ Raw wood of 6 mm thickness or less.</li> <li>▪ Processed wood produced by glue, heat and pressure, or a combination thereof.</li> <li>▪ Plywood sheets &amp; agglomerated sawdust sheet.</li> <li>▪ Oriented wooden fibre sheets.</li> <li>▪ Sawdust &amp; Wooden fibre.</li> </ul> </li> <li>▪ Items which may adversely be affected by the fumigation chemicals, should be tightly wrapped and sealed in plastic prior to the shipping.</li> <li>▪ An ISPM 15 internationally recognised certification mark must include the following: <ul style="list-style-type: none"> <li>▪ IPPC certification symbol (this is a registered trademark).</li> <li>▪ XX: represents the two letters ISO country code where the wood was treated.</li> <li>▪ 000: represents the unique certification number (which ensures that the wood packaging material can be traced back to the treatment provider and/or manufacturer).</li> <li>▪ YY: is the treatment abbreviation where: <ul style="list-style-type: none"> <li>▪ HT: is the code for heat treatment</li> </ul> </li> </ul> </li> </ul>
