<b>Motor Vehicles</b>	<ul style="list-style-type: none"> <li>▪ Original registration documents</li> <li>▪ Invoice or pro-forma invoice with vehicle's value</li> <li>▪ All technical information (chassis number, weight, power, etc.).</li> </ul>	<ul style="list-style-type: none"> <li>▪ Special tax "Trošarina" has to be paid at time of importation (except for diplomats).</li> <li>▪ Vehicles must have been owned for min. 6 months.</li> </ul>	
<b>Restricted and prohibited items</b>		<ul style="list-style-type: none"> <li>▪ Prohibited or very restricted items include: <ul style="list-style-type: none"> <li>▪ drugs,</li> <li>▪ flammables,</li> <li>▪ toxins,</li> <li>▪ poisons,</li> <li>▪ explosives,</li> <li>▪ firearms,</li> <li>▪ ammunition,</li> <li>▪ radioactive material,</li> <li>▪ corrosives</li> <li>▪ etc.</li> </ul> </li>   <li>▪ Regulated, restricted and dutiable items include: <ul style="list-style-type: none"> <li>▪ plants,</li> <li>▪ high-value artwork,</li> <li>▪ food,</li> <li>▪ liquids,</li> <li>▪ medicinal products,</li> <li>▪ alcohol, etc.</li> </ul> </li> </ul>

<p><b>Pets</b></p>	<ul style="list-style-type: none"> <li>▪ ID by tag, tattoo or microchip</li> <li>▪ Valid passport for pet animals</li> <li>▪ Veterinarian's certificate.</li> </ul>	<ul style="list-style-type: none"> <li>▪ They will be examined by a border veterinary inspector.</li> </ul>
