<p><b>Personal effects – non-diplomatic shipments</b></p>	<ul style="list-style-type: none"> <li>▪ Copy of passport with entry visa</li> <li>▪ Packing list in English</li> <li>▪ Recommendation letter from the shipper's employer in Libya to Libyan Customs.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Books and computer accessories require approval at destination; therefore a list of book titles is required.</li> <li>▪ Computers are subject to authorization from the Security Department. Only the client through his/her company/organization can apply.</li> </ul>	<ul style="list-style-type: none"> <li>▪ No tax on diplomatic shipments</li> <li>▪ No tax on used personal effects shipment.</li> </ul>
<p><b>Personal effects –diplomatic shipments</b></p>	<ul style="list-style-type: none"> <li>▪ Copy of diplomatic passport</li> <li>▪ Packing list in English</li> <li>▪ Diplomatic exemption to be requested by the diplomatic mission</li> <li>▪ Copy of the statistical registration card of the diplomatic mission.</li> <li>▪ The customs form to be stamped by the shippers organisation in Libya</li> </ul>		<ul style="list-style-type: none"> <li>▪ No tax on diplomatic shipments</li> <li>▪ No tax on used personal effects shipment.</li> </ul>
<p><b>Vehicles</b></p>	<ul style="list-style-type: none"> <li>▪ Registration documents</li> <li>▪ Commercial invoice.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Customs tax of approximately 10% of the commercial value applies to all non- diplomatic vehicles.</li> <li>▪ 4x4 Vehicles pay up to 50% tax.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Vehicles must not be more than 9 years old when handled from Tripoli port; and not more than 10 years old when handled from Misurata port.</li> </ul>
<p><b>Prohibited items</b></p>		<ul style="list-style-type: none"> <li>▪ Alcohol</li> <li>▪ Drugs</li> <li>▪ Pornographic materials</li> <li>▪ Firearms</li> </ul>
