<p><b>Removal goods</b></p>	<ul style="list-style-type: none"> <li>▪ Original change of residence certificate issued by local authority from country of departure.</li> <li>▪ Valued inventory in French or Arabic.</li> <li>▪ Packing-list detailed dated and signed.</li> <li>▪ Work contract or original attestation from Moroccan company.</li> <li>▪ Copy of passport with stamp of entry Morocco.</li> <li>▪ Sworn Statement stating these are used goods (original doc required) + POA with legalized signature (template given by Moroccan mover).</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty free entry if goods have been in owner's possession and used for more than 6 months.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Moroccan Consulate must stamp same documents in place of departure for Moroccan people.</li> <li>▪ CCR has to be on city hall's paper head, signed and stamped.</li> <li>▪ CCR can be done in most consulates / embassies in Morocco. Check with your destination agent before departure.</li> </ul>
<p><b>Diplomats' removals</b></p>	<ul style="list-style-type: none"> <li>▪ Franchising delivered by Ministry of Foreign Affairs in Rabat (in French).</li> <li>▪ Inventory in French or Arabic, stamped by the diplomatic entity.</li> <li>▪ Copy of passport.</li> <li>▪ Power of Attorney, on diplomatic entity letterhead and stamped.</li> <li>▪ Sworn Statement, on diplomatic entity letterhead and stamped.</li> <li>▪ Verbal note (from a diplomatic entity).</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty free entry even for new furniture.</li> <li>▪ For alcohol, see under the wine/alcohol section.</li> </ul>	
<p><b>Wedding trousseaux</b></p>	<ul style="list-style-type: none"> <li>▪ Wedding certificate.</li> <li>▪ Original certificate of change of residence.</li> <li>▪ Inventory in French or Arabic.</li> <li>▪ Proof of residence in Morocco for your</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty free entry except for new items.</li> </ul>

	<ul style="list-style-type: none"> <li>husband/wife.</li> <li>▪ Power of Attorney, legalized signature.</li> <li>▪ Sworn Statement, original letter required.</li> </ul>		
<b>Inheritance</b>	<ul style="list-style-type: none"> <li>▪ Notary act giving name of the deceased and his family relationship with the heir.</li> <li>▪ Inventory delivered by notary.</li> <li>▪ Copy of heir's passport.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Same as above.</li> </ul>	
<b>New articles</b>	<ul style="list-style-type: none"> <li>▪ New articles invoice.</li> <li>▪ Packing List.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Subject to duty and taxes.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Depends on items' category.</li> <li>▪ You can count on 50 % more or less.</li> </ul>
<b>Antiques, works of art</b>	<ul style="list-style-type: none"> <li>▪ Detailed and valued inventory.</li> <li>▪ Authorisation issued by Ministry of the Cultural Affairs.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty free entry when used and part of removal goods.</li> </ul>	
<b>Motor vehicles, motor cycles, boats, caravans</b>	<ul style="list-style-type: none"> <li>▪ Original of title certificate.</li> <li>▪ Original passport.</li> <li>▪ Purchase invoice.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Diplomats: <ul style="list-style-type: none"> <li>▪ Free entry with franchising letter.</li> <li>▪ Whether used or new car.</li> </ul> </li> <li>▪ Non diplomats: <ul style="list-style-type: none"> <li>▪ Temporary import: <ul style="list-style-type: none"> <li>▪ Free if car is less than 5 years old.</li> <li>▪ Temporary import is limited to 6 months per calendar year.</li> </ul> </li> <li>▪ Regular import: <ul style="list-style-type: none"> <li>▪ Around 50 % taxes and duties.</li> <li>▪ Car has to be less than 5 years old.</li> </ul> </li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ Only diplomats can import a car older than 5 years old.</li> </ul>
<b>Dogs and cats</b>	<ul style="list-style-type: none"> <li>▪ Certificate of vaccination (vaccination against rabies required for dogs only).</li> <li>▪ Health certificate.</li> <li>▪ Owner's passport copy.</li> </ul>		
<b>Plants</b>	<ul style="list-style-type: none"> <li>▪ Phytosanitary certificate.</li> </ul>		<ul style="list-style-type: none"> <li>▪ Avoid plants because the authority delivering the certificate is complex and</li> </ul>

<b>Hunting arms</b>	<ul style="list-style-type: none"> <li>▪ Hunting permit.</li> <li>▪ Firearm acquisition certificate.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty free entry when used and part of removal goods.</li> </ul>	<ul style="list-style-type: none"> <li>▪ If documents are not produced, arms will be retained at customs.</li> </ul>
<b>Books, records, cassettes</b>			<ul style="list-style-type: none"> <li>▪ No list required.</li> </ul>
<b>Wine, alcohol</b>		<ul style="list-style-type: none"> <li>▪ 25 to 30 bottles admitted as “fond de cave” if part of your removal.</li> <li>▪ What is allowed for a foreigner: <ul style="list-style-type: none"> <li>▪ 15 “opened” bottles (e.g. opened whisky bottle) + 15 unopened bottles.</li> <li>▪ Indicate ‘fond de cave’ on the packing list.</li> </ul> </li> <li>▪ What is allowed for a diplomat: <ul style="list-style-type: none"> <li>▪ 19 boxes of alcohol (pack of 6 or 12 bottles).</li> <li>▪ Indicate ‘fond de cave’ on the packing list.</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ Bottles cannot be in new cases. They have to be bought some time ago.</li> </ul>
<b>Narcotics, drugs</b>		<ul style="list-style-type: none"> <li>▪ Prohibited entry.</li> </ul>	
<b>Tins &amp; food</b>		<ul style="list-style-type: none"> <li>▪ Small quantities admitted as part of removal goods.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Avoid canned food and pet food, customs can request analyse from agricultural ministry which costs time and money.</li> </ul>
<b>Books and magazines: Pornographic and Politics against Morocco’s kingdom + islamophobics</b>		<ul style="list-style-type: none"> <li>▪ Prohibited entry.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Maps showing the southern provinces of Morocco separated from the northern ones and named Western Sahara will be confiscated.</li> </ul>
<b>Cellular or cordless telephones, fax machines, satellite talkie-walkie</b>	<ul style="list-style-type: none"> <li>▪ A declaration/certificate has to be made to authorities ONTT and “Maroc Telecom”.</li> </ul>

<b>Drones</b>		<ul style="list-style-type: none"> <li>▪ Prohibited entry.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Any flying objects without pilot are to be considered as drone, even kids toys.</li> </ul>
