			<ul> <li>Fish</li> <li>Sweets</li> <li>Paint</li> <li>Products made of cereals (biscuits, pasta, noodles, etc.)</li> <li>Leather items (raw or sleeked)</li> <li>Silk and products derived from it</li> <li>Articles containing feathers and artificial flowers</li> <li>Umbrellas and walking sticks</li> <li>Straw items</li> <li>Dairy products and eggs, except powdered milk</li> <li>Plastic items</li> <li>Trees, plants, natural flowers.</li> <li>Note: all items on this list are permitted as imports if they are personal effects. Please note that due to this temporary prohibition, some of these items are difficult to find, expensive or of poor quality.</li> </ul>
Pets (dogs, cats, birds)			<ul> <li>Transportation of pets can be arranged as accompanied luggage on your return flight. In this case, contact the airline for the official procedure.</li> <li>Contact a carrier that specialises in the transportation of animals.</li> </ul>
